As one of the most prominent contemporary authors, Hosseini combines literary artistry with profound psychological depth. His major works — *The Kite Runner* (2003), *A Thousand Splendid Suns* (2007), and *And the Mountains Echoed* (2013) — present a complex portrayal of adolescence, identity formation, trauma, and resilience amid war, displacement, and social oppression. Using psychoanalytic and developmental frameworks from Freud, Jung, Erikson, and Piaget, this paper investigates how Hosseini's characters embody universal psychological conflicts such as guilt, repression, and moral awakening. Through a qualitative literary analysis, the research reveals that Hosseini's narratives blend psychological realism with cultural authenticity, turning fiction into a medium for empathy, healing, and moral reflection.

His novels not only narrate personal and national tragedies but also illuminate how external forces—such as war, patriarchy, and displacement—shape the psychological development of young individuals. This research focuses on the psychological portrayal of youth in Hosseini's *The Kite Runner*, *A Thousand Splendid Suns*, and *And the Mountains Echoed*. It aims to examine how the author integrates psychological theories into his narratives, particularly concerning trauma, guilt, and emotional recovery, and how these elements contribute to the universal human experience of growth and self-discovery.

Main part. Adolescence and Identity in *The Kite Runner*. In *The Kite Runner*, Hosseini examines the fragile formation of identity through the character of Amir, whose childhood experiences of betrayal and guilt shape his adult life. Erik Erikson's psychosocial theory identifies adolescence as the stage of “identity versus role confusion,” where the individual strives to define their moral and social position. Amir's struggle to earn his father's approval, his failure to protect his loyal friend Hassan, and his lifelong search for redemption reflect the universal psychological conflict between self-perception and moral responsibility.

Freud's concept of repression also manifests in Amir's recurring guilt and dreams, symbolizing the lingering effects of unresolved trauma. Hosseini portrays Amir's psychological evolution with remarkable realism, inviting readers to empathize with his moral awakening and eventual

reconciliation. In *A Thousand Splendid Suns*, Hosseini shifts focus to the inner lives of Afghan women—Mariam and Laila—whose adolescent experiences are marked by social inequality and patriarchal oppression. From a Piagetian perspective, both characters undergo cognitive and emotional growth, developing self-awareness amid restrictive cultural conditions. Their resilience in the face of violence and loss highlights the intersection of psychological endurance and gendered struggle. Through these female characters, Hosseini portrays adolescence as both a site of suffering and empowerment. Despite external limitations, Mariam and Laila demonstrate an evolving capacity for emotional strength, which aligns with Jung’s archetype of the “wounded healer.” Their inner transformation serves as a symbolic act of resistance and hope. In *And the Mountains Echoed*, Hosseini extends his psychological exploration to childhood separation and intergenerational trauma. The story of siblings Abdullah and Pari exemplifies how early emotional wounds can shape one’s entire life trajectory. The narrative reflects Moshman’s theory of autobiographical memory, suggesting that childhood trauma contributes to moral and emotional development throughout adulthood. Hosseini employs trauma psychology to depict loss and adaptation, using fragmented storytelling and multiple perspectives to mirror the complexity of human memory. The novel thus serves as a literary case study of how individuals internalize grief and reconstruct identity after separation.

Discussion. The analysis reveals that Hosseini’s protagonists embody the journey from trauma to transformation. In *The Kite Runner*, Amir’s moral redemption echoes Freud’s concept of catharsis, while in *A Thousand Splendid Suns*, Laila and Mariam’s endurance represents collective resilience under patriarchy. Jung’s idea of individuation—the process of integrating the conscious and unconscious—can be seen in characters who evolve by confronting their inner pain. Hosseini’s blending of psychological and cultural narratives elevates his work beyond national boundaries, demonstrating literature’s power to foster empathy and emotional healing. His novels thus operate as therapeutic texts, providing readers a reflective space to process universal emotions of loss, guilt, and forgiveness.

Conclusion. Khaled Hosseini’s novels are distinguished by their emotionally vivid and psychologically layered depictions of adolescence. His characters navigate trauma, cultural conflict, and personal growth in ways that are both universal and culturally specific. The Uzbek translations of these novels successfully transmit much of this emotional depth, yet at times fall short in preserving the intricate psychological and cultural layers embedded in the original texts.
